Guidance on Searching within Online Documents

Portable Document Format / pdf / Adobe

Click on the Search button (illustrated with binoculars). This will open up a search window. Type in the term you need to find and links to all of the references to that term within the document will be displayed in the window. You can jump to each reference by clicking it. You can search for more terms by pressing 'search again'.

Word documents

Select Edit from the menu, the Find and type in your term in the search box which is presented. The search function will locate the first use of the term in the document. By pressing 'next' you will jump to further references.

The article looks at: Manchester's city regions and their one-stop shops for children under five; Croydon's focus on children from prenatal to seven-years of age; Bradford who are focusing on young people leaving care or custody; Coventry, Solihull and Warwickshire's theme to remove duplication in children's services with better integrated services; and Birmingham who are testing parenting techniques from overseas, including The Incredible Years programme.

Abstract: This is essentially a report of the results of 13 pilot studies designed to test concepts of a 'total place' approach to the delivery of health and social services. Local authorities in each of the pilot areas were encouraged to examine a range of their public services and given the freedom to make changes calculated to improve service, reduce cost or both. Within the 13 pilot areas some 63 local authorities and 34 primary care trusts were involved, together with 12 fire and 13 police authorities. The three main planks of the total place approach are financial flexibility, performance improvement and reduction in the burden of work associated with reporting, inspection and performance monitoring. Five key points are listed as reasons for change. In four of these the reduction of complexity or the management of complex needs is a common theme. From the user viewpoint the difficulty of access to information on services or citizens rights to those services is an issue raised here.
