Portable Document Format / pdf / Adobe

Click on the Search button (illustrated with binoculars). This will open up a search window. Type in the term you need to find and links to all of the references to that term within the document will be displayed in the window.

Word documents

Select Edit from the menu, the Find and type in your term in the search box which is presented. The search function will locate the first use of the term in the document. By pressing 'next' you will jump to further references.

Abstract: The article reflects on community care legislation in Great Britain, the section 117 of The Mental Health Act 1983. It opines that Section 117 is the sore thumb of community care legislation as it obliges councils and the National Health Service to provide aftercare services for people discharged after treatment under the Mental Health Act 1983. It comments that councils dealing with older people often ignore the condition that section 117 services must be provided free of charge.

Abstract: The aim of this study is to investigate the level of awareness amongst consultants regarding Mental Health Act (MHA) Section 117 aftercare, their responsibilities and current practice. We conducted a cross-sectional survey alongside a retrospective study of the Trust Section 117 aftercare registers. Seventy-four per cent of the consultants were aware of the Section 117 aftercare registers and the need for review of aftercare. Ninety-four per cent were aware of the financial implications of Section 117. However, only 52% of the consultants regularly contributed to the review process to identify patients who were no longer in need of aftercare under Section 117. Over a five-year period, 150 patients were discharged from Section 117, of whom only 4% were officially discharged following review of the care plan. Health and social services have a legal obligation to provide aftercare to all eligible patients free of charge under Section 117. With the new Mental Health Act 2007 this will now include patients on Supervised Community Treatment Orders. It is important to have a clear understanding of Section 117 to ensure patients' needs are met and to allow effective use of resources.

3. Call to end 'bizarre' discrepancy under new Mental Capacity Act.

Abstract: The article reports on the call of the Royal College of Psychiatrists of Great Britain for an end to discrepancies between laws used for detaining mental health patients. Under the Bournewood proposals, patients with dementia, learning difficulties or autism who are detained under the Mental Capacity Act will be means-tested before being given aftercare, while patients sectioned under the Mental Health Act will get their aftercare for free.

carried out because of concerns that the voices of such service users were not being heard in research, policy or practice. The overall aim is to produce recommendations for good practice that enable the expertise of this largely hidden group to be included in the planning and provision of effective services. It outlines the aims and objectives of the research and then describes the context of increasing concern about dangerousness within which it took place, a fact noted by the following service user, who also identified more salient risk factors than mental state, namely age and gender: "But, again, from the kind of general voice of users who say 'Well, actually, most of us find that a little bit kind of strong to somehow say because one's had mental health problems, you're immediately

3. An investigation into the practice and benefits of statutory aftercare in an inner city psychiatric service

Abstract: The implementation of statutory aftercare for psychiatric inpatients, as outlined in Section 117 of the Mental Health Act 1983 (England and Wales), was studied by examining current practice in an inner city psychiatric service. Seventy-seven per cent of patients received Section 117 aftercare; 56% of patients did not have an identified key worker. A significant proportion of those receiving statutory aftercare did not have evidence of adequate forward planning. General practitioners did not attend any meetings. Patients who had Section 117 aftercare were compared with those who did not. Using the Cox regression model, it was found there was no significant difference between these two groups in terms of time between discharge and first readmission, readmission rate, and length of first readmission.
